



AUDIT REPORT

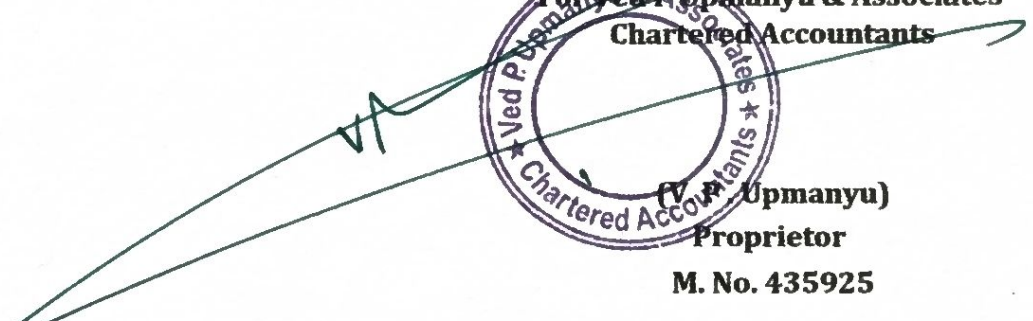

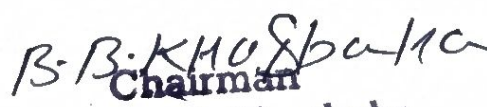

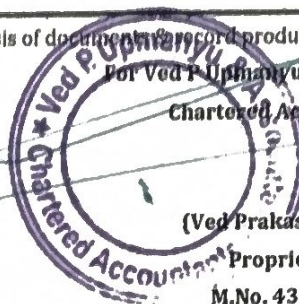
