In the year 2022-23, the organisation reached thousands of beneficiaries across Sundergarh and nearby regions through various impactful programs.

Mission & Vision:

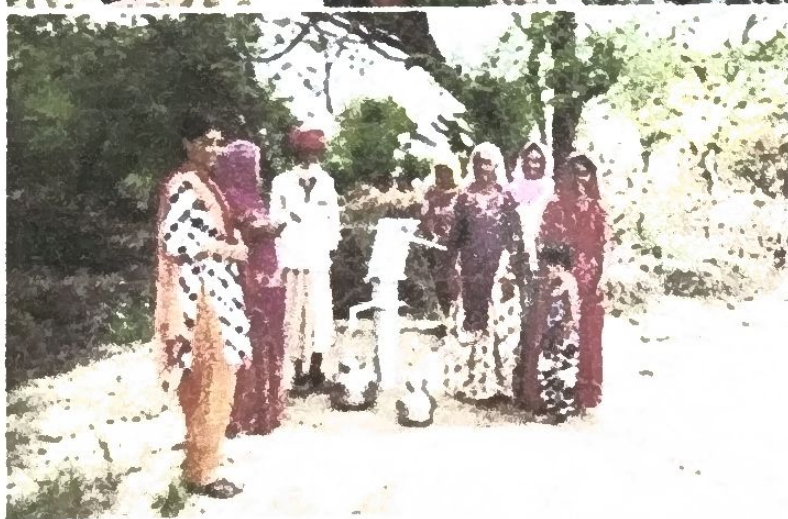
Our Mission is to safeguard and promote human rights, ensuring equality, justice, and dignity for every individual. We aim to create awareness, provide support to vulnerable communities, and advocate for policies that strengthen human rights.

Our Vision is to build a society free from violence, exploitation, and discrimination, where human rights are respected and every person can live with dignity and peace.

Programs 2023-24

Human Rights Awareness Program

The organisation conducted awareness campaigns in schools, colleges, and rural areas to spread knowledge about constitutional and human rights. Special training sessions for youth and volunteers were organized to strengthen their ability to address rights violations. Street plays, seminars, and rallies were used as tools for mass engagement. The program focused on educating marginalized communities about their right to equality and justice. Nearly 3,500 people benefitted directly this year.



Domestic Violence Program

The program addressed issues of domestic abuse by offering counseling, legal support, and community outreach. Victims were provided with safe spaces and guidance on their rights under existing laws. Awareness drives emphasized zero tolerance toward violence in families and workplaces. Collaboration with local police and women's cells ensured quick response to cases. This initiative supported more than 600 women, restoring confidence and dignity in their lives.

Child Rights Welfare Program

Efforts were focused on protecting children from exploitation, neglect, and abuse. The organisation organized educational workshops to highlight the importance of schooling and nutrition for children. Anti-child labor campaigns were conducted in local markets and industrial areas. Support was provided to parents and guardians to prevent child marriage and unsafe practices. Over 1,500 children benefitted, gaining access to better education and safety measures.

Women Rights Awareness Program

The program empowered women with knowledge of their legal, social, and economic rights. Special workshops on workplace equality, harassment laws, and access to government schemes were held. Women were trained in leadership and encouraged to join decision-making processes in community development. Legal literacy camps made women aware of court procedures and free legal aid services. Nearly 1,000 women actively engaged and benefitted from this initiative.



Anti-Human Trafficking Initiative

This initiative focused on prevention, rescue, and rehabilitation of trafficking victims. Community watch groups were formed in vulnerable regions to monitor and report suspicious activities. Training programs educated families and youth about the risks and tactics of traffickers. Victims received counseling, shelter, and vocational training for rehabilitation. With collaborative efforts, several potential trafficking cases were stopped, and many survivors were reintegrated into society.

RTI Act Rights Awareness

The organisation promoted transparency and accountability by educating citizens about the Right to Information (RTI) Act. Awareness sessions guided participants on how to file applications and seek information from public offices. Practical demonstrations were conducted to make the process easier for rural people. The campaign strengthened democratic participation by empowering citizens to question governance. Around 500 people began actively using RTI as a tool for justice this year.



Achievements & Impact (2024-25)

- Benefitted over 9,000 individuals through direct interventions and awareness programs.
- Expanded scope of programs by introducing the Health Awareness Program.
- Built stronger collaboration with local authorities, schools, and healthcare providers.
- Enhanced community participation in human rights, health, and women's safety initiatives.

Future Goals (2025-26 & Beyond)

- Establish permanent legal aid and counseling centers in Sundergarh.
- Expand health initiatives with mobile medical units for remote villages.
- Launch skill development and employment programs for youth and women.
- Integrate environmental sustainability into social welfare projects.
- Strengthen partnerships with national and global human rights organisations.
